

Automatic Renewal Membership Payment Information

The option to enroll in the WIFS membership auto-renewal/recurring payment program is extended to all individuals except those associated with special or complimentary memberships. The member's credit card information is securely collected, transmitted and maintained with the credit card processor. Membership for individuals who opt-in to participate in the auto-renewal/recurring payment program will be automatically renewed each January 1st at the current National and applicable Chapter dues rates. Individuals enrolled in the program are responsible for maintaining current credit card information. Failed credit card transactions will result in pending membership status until resolved.

WIFS does not maintain or have direct access to credit card information for those enrolled in the auto-renewal program. Enrolled members are responsible for maintaining current credit card information. Receipts for processed renewal transactions will be sent to the member's email address on file. Failed credit card transactions will result in pending membership status until resolved.

Program participants will receive an email reminder, that includes information on opting out and updating credit card information, between November and December each year. Requests to opt out/cancel participation in the auto-renewal/recurring payment program must be communicated to WIFS National via email to office@wifsnational.org on or before December 21st.

Monthly Installments FAQ

- 1. What is "Monthly Installments" and how does it work?** - Monthly installments allow our members to pay for their national and chapter dues throughout the year, instead of paying for their entire membership at once. It's our way of making our membership more accessible for everyone to join.
- 2. So it's a monthly membership?** - No. When you register, you are signing up for the full year of membership. This means that your membership payment is spread out throughout the year.
- 3. When is the money taken out of my account?** – Your first charge will be the day you register for Monthly Installments. Each month after, you will be charged at the beginning of each month for the remainder of the year. If you register in November or December 2020, you will be charged for your first month, and your next charge will be in February.
- 4. How much is my membership per month?** – You can scroll down to see the pricing chart for Monthly Installments! Your monthly payment is based on the month you register. That payment will stay the same until the end of the year, once your membership is paid entirely.
- 5. Can I cancel my membership and payments anytime?** - Yes, but you will not be refunded for the payments you already made throughout the year.

6. **Can I still sign up for auto renewal?** - Yes! Auto renewal is available for both monthly installments and annual payments. Signing up for auto renewal will automatically renew your membership at the end of the year, so you don't have to think about it!
7. **Can I switch to monthly installments from annual if I already automatically renewed?** - Yes. Please reach out to National to discuss how this can be done.
8. **Can I pay the remainder of my membership halfway through the year?** - Sure! Send the National team an email or a phone call to discuss how we can process the remainder of your membership payments.
9. **What happens if I can't pay for the month?** - The National office will give you a one month leeway to pay your membership dues. If you are unable to pay for your membership dues over three months, your membership will be canceled and no refund will be issued.
10. **I'm a chapter leader, what's my role in this?** - As a chapter leader, we are asking that you help us ensure that people are getting their payments in. If someone is late with payments, we will let you know and ask you to reach out to them. If we do not receive their payment after three months, we will inform you that their membership will be canceled.

The monthly installment prices are also based on the month they join and is the set monthly due price for the remainder of the year. The WIFS membership year is January 1–December 31st.
